REGULATIONS

ART.1

Film Works of any nationality may participate in the Festival.

ART.2

The festival is divided into two phases

ONLINE SELECTIONS - FINAL EVENT with AWARD CEREMONY.

SELECTIONS

Participants will register their Work for the Festival by the deadlines indicated on the website www.cortidamare.com and the material received will be selected by a Technical-Artistic Committee.

Short Films (Fiction / Animation) must have a maximum duration of 15' excluding Head and End Titles.

Documentaries, Interviews, Docufilms should have a maximum duration of 50'excluding Head and End Credits.

Videoclips shall have a maximum duration of 4' excluding Head and End Titles.

FINAL EVENT with AWARD CEREMONY.

The Finalist Works, selected by a Jury of Experts and a Popular Jury, will be screened during an Event where the authors, protagonists, directors and producers will be interviewed.

During the Awards Ceremony, the Trailers of the top three winners in each Category will be screened, in an order of screening that will be agreed upon by the Juries.

Following this, Awards will be presented to the Winners, with the Jury of Experts reserving the right to award Special Prizes to particularly deserving and talented authors, directors, protagonists, to innovative productions, to Works dedicated to the enhancement of the territory in which they were made.

The Popular Jury Prize will be awarded to the most exciting Work.

ART.3

The Application Form, duly completed via Form on the website www.cortidamare.com,

must be submitted by December 18, 2024.

Works should be submitted via downloadable link (YouTube, Vimeo, etc.) in Mp4 FullHD format.

ART. 4

Participants must attach to the application all the documentation requested in the Form including the SIAE release for the music and the release for the images.

The Registration fee is euro 20.00 (Twenty.00).
